### INSTRUCTIONS TO ROS ON PSC DETENTIONS AND SURVEYS

### Improvement of Safety Standards onboard Belizean Vessels

Notice to Owners, Recognized Organizations, Deputy Registrars, Resident Agents and those concerned with the registration of vessels under the Belize Flag and their documentation.

Technical Note Superseded: N/A

**ISSUE DATE:** March 3, 2004

The present instructions aim at enhancing the control of the flag state over safety standards of Belizean ships. These are complementary to any authorizations given in the past to Recognized Organizations. All terms used are as defined in international conventions for the implementation of which relevant authorizations have been given to Recognized Organizations.

#### 1. SURVEYS AFTER A PSC DETENTION

- 1.1. When a Belizean flag ship is detained and the RO is called to attend either by IMMARBE or PSC, the surveyor of the RO shall not limit the inspection to the deficiencies noted by the Port State Control.
- 1.2. If the date of the detention falls within the  $\pm$  3 months window for statutory surveys other than the renewal surveys, they shall be completed before the ship sails.
- 1.3. If the date of the detention falls within the 3 months prior to the due date of the renewal surveys, they shall be conducted to the extent possible before the ship sails, except for safety equipment and radio, which shall be completed. A time schedule for the completion of surveys at the next convenient port shall be set and their completion shall not be delayed until the end of the window.
- 1.4. If the date of the detention does not fall within the  $\pm$  3 months' window for statutory surveys, the RO surveyor, after clearing the PSC deficiencies, shall carry out a general examination of the vessel including the items listed in Appendix 1 and shall complete the questions listed in Appendix 2. Then using professional judgment the surveyor shall decide if any in-depth survey is required.
- 1.5. In cases where the surveyor deems that in-depth surveys are required, a safety equipment renewal survey and annual surveys for the other statutory certifications are to be carried out. The RO shall send to the Belize Administration copies of the reports on such cases.

# 2. SURVEYS AFTER A PSC INSPECTION WHERE THE DEFICIENCIES FOUND DID NOT WARRANT DETENTION

- 2.1. The Belize Administration performs a weekly fleet PSC assessment where the vessels inspected and found with deficiencies under the major MoUs go through a risk analysis to decide whether the case warrants further investigation.
- 2.2. In the cases where the RO is called to attend as a result of the risk analysis made by the Belize Administration, the RO shall proceed following the same guidelines as for the case of a PSC Detention (1).

### 3. REPORTING AND RECTIFICATION OF DEFICIENCIES

3.1. Deficiencies cited by the Belize Administration or in PSC detention reports received by the Belize Administration will be communicated to the relevant RO(s) performing statutory certification of the ship and the latter are to verify that the deficiencies are rectified according to a set schedule. Otherwise the RO is to contact the Technical Department of IMMARBE for a decision on the action to be taken.

#### 4. ISM

- 4.1. Where a ship has been detained and the PSC inspection report explicitly references an ISM major non-conformity, an auditor of the auditing organization shall board the vessel and perform an additional audit of the vessel's Safety Management System, SMS. The extent of this additional audit should be:
  - 4.1.1. Equivalent to the mandatory initial audit of the shipboard part of the SMS, in case the major non-conformity is identified within twelve months or less from the date of the initial/renewal audit or less than six months prior to the renewal audit, or
  - 4.1.2. Equivalent to the mandatory intermediate audit of the shipboard part of the SMS, in case the major non-conformity is identified twelve months or more from the date of the initial/renewal audit or more than six months prior to the renewal audit.
- 4.2. If during the shipboard audit, it becomes apparent that problems also exist with the SMS of the Company, an additional audit to the extent of the annual audit shall be performed for the Company.
- 4.3. If the detention order contains no explicit reference to the ISM non-conformities, then the surveyor shall act as in section (1).
- 4.4. If the RO doing the ISM certification is different from the RO doing the other statutory certifications, then the auditing surveyor, having obtained the answers to the questions on Appendix 2, should notify the Technical Department of IMMARBE who is to notify the RO doing the ISM certification of the findings. In case the auditing organization, having assessed the findings, deems that an additional audit is necessary, it shall notify the Technical Department of IMMARBE and the

RO doing the other statutory certifications and proceed as soon as possible to conduct the additional audit of the SMS of the ship. Audit results should be also reported.

- 4.5. If the RO doing the ISM is also doing the other statutory certifications, then in case the RO having assessed the findings of the surveyor based on the answers to questions in Appendix 2, deems an additional shipboard audit is necessary, the RO shall notify immediately the Technical Department of IMMARBE and proceed as soon as possible to conduct the additional audit of the SMS of the ship and inform the Technical Department of IMMARBE of the results.
- 4.6. If a vessel is justifiably detained twice within 12 months, then an additional shipboard audit in the scope of an intermediate audit shall be performed for the vessel's SMS and an additional audit of the Company, in the scope of an annual audit.
- 4.7. The Technical Department of IMMARBE shall be notified in advance prior conducting any additional shipboard audit or additional audit of the Company.
- 4.8. The Technical Department of IMMARBE shall decide the extent and scope of additional audits of the shipboard as well as the shore based SMS of a Company, when a large proportion of that Company's fleet is detained by PSC.

#### 5. POSTPONEMENT OF RENEWAL SURVEYS

- 5.1. Applications for postponement of the renewal survey will be considered exclusively by the Belize Administration only in cases where special circumstances warrant them.
- 5.2. No postponement of the renewal survey shall be given unless all surveys have commenced and proceeded to the extent possible. The Technical Department of IMMARBE may decide to deviate from this course of action only in cases of force majeure.
